Entries: Entries must be received by **Wednesday, April 16, 2008**. Space for each event is limited; events will close when the player limit is reached. Events, with players' names, will be posted on the SPTTC web site, <http://www.spttc.org>. Entries without payment will not be accepted.

Refunds: Full refund for cancellations received by Wednesday, April 16, 2008. No refunds after the deadline (subject to tournament committee review).

Rules: All USATT regulations apply. USATT dress code applies – no **WHITE** shirts. Matches must be played in order for you to be eligible for prizes. You may not split prize money with your opponent in lieu of playing.

Equipment: Only USATT approved equipment will be used; tables will be (12) Butterfly; nets will be Butterfly; balls will be 40mm **WHITE** Butterfly 3-star; floor is wood. Balls are provided courtesy of Butterfly.
Facility: Courts will be **38** feet long with **10** feet between tables, partially barriered. Gym is air conditioned/heated.

Fundraiser: Events 11-13 will be used as a fundraiser for the Francis Howell School District (FHSD) table tennis program(s). All monies received from entry fees will go back to the school district.



Schedule: Gym will be open at 8:00am for practice and warm-up. You must check in at least 30 minutes prior to your first event, or you may be removed from the event.

All events are 11 point games, best 3 out of 5. The tournament committee reserves the right to modify event formats and player entries. All unrated players, playing in USATT-sanctioned events, will be given an estimated rating for seeding purposes. However, unrated players competing in an USATT-sanctioned event will **NOT** advance out of their round robin to crossover competition, nor win awards (cash/trophy). The latest ratings from the USATT web site will be used, where possible. Do **NOT** enter events with the same start time.

Event 1: Giant round robin singles will be limited to 64 players. It will be broken into eight (8) groups of eight (8) players each based on ratings. The top 8 players will be put in the Class A division, the next 8 highest rated players will be put in Class B division, etc. The tournament committee reserves the right to determine where the rating cutoff will occur for each division and how many divisions will be played based on the number of entries. The latest ratings available from the USATT web site will be used. It is possible to have one division with 10 players and another with 6 players, if the disparity in ratings is too great to be competitive. **Players rated under 1500 will start at 9:00am. Players rated over 1500 will start at 1:30pm. You will receive e-mail confirmation (or a phone call) letting you know of your start time if you are near 1500.**

Events 2, 4, 5, 7 & 8: Open, U-1800, U-1600, U-1200, and U-1000 will each be limited to 20 players. Round robin groups of 4 will compete with the top player advancing to crossover play. Ratings from the USATT web site on **March 28, 2008** will be used for the division cutoffs. However, the latest ratings available from the USATT web site will be used for seeding.

Events 3 & 6: U-2000 and U-1400 will each be limited to 24 players. Round robin groups of 4 will compete with the top player advancing to crossover play. Ratings from the USATT web site on **March 28, 2008** will be used for the division cutoffs. However, the latest ratings available from the USATT web site will be used for seeding.

Event 9: The Open Doubles RR is limited to 8 teams. Round robin groups of 4 will compete with the top 2 teams advancing to crossover semifinals. You must be a USATT member. You are limited to only one (1) doubles event.

Event 10: The U-3200 Doubles RR is limited to 8 teams. The combined rating of the team must not exceed 3200. Ratings from the USATT web site on **March 28, 2008** will be used for the 3200 cutoff. Round robin groups of 4 will compete with the top 2 teams advancing to crossover semifinals. You must be a USATT member. You are limited to only one (1) doubles event.

Event 11: The Novice Singles RR is limited to non-USATT members. This is a non-sanctioned event and does **NOT** require USATT membership. This event will be limited to 20 players. Round robin groups of 4 will compete with the top player advancing to crossover play.

Event 12: The Novice Doubles RR is limited to non-USATT members. This is a non-sanctioned event and does **NOT** require USATT membership. This event will be limited to 8 teams. Round robin groups of 4 will compete with the top 2 teams advancing to crossover semifinals. You are limited to only one (1) doubles event.

Event 13: The FHSD-only Singles RR is limited to students/staff associated with the Francis Howell School District (FHSD). This is a non-sanctioned event and does **NOT** require USATT membership. This event will be limited to 12 players. Round robin groups of 3 will compete with the top player advancing to crossover semifinals.
